

My Surgery Website – Service Terms and Conditions

My Surgery Website endeavours to provide its clients with the highest level of service at all times.

Contact

My Surgery Website undertakes to respond to all email communication from clients within five working days of receipt.

Purchases

By purchasing an annual licence the client is entitled to full access to the My Surgery Website product for one year. The product comprises

• A web-based service hosted on a server backed by service level agreements providing for the following:

- ✓ The network will be available 100% of the time in a given month, excluding schedule maintenance.
- ✓ The critical infrastructure systems, including power and HVAC, will be available 100% of the time in a given month, excluding scheduled maintenance.
- ✓ Functioning of all hardware components and replacement of any failed component within two hours of notification to the hosting provider.

• Telephone support during office hours 9am - 5pm Monday to Friday excluding Bank Holidays.

• Email support during office hours 9am - 5pm Monday to Friday excluding Bank Holidays.

• Access to all updates, improvements and additions to the product or intranet made by My Surgery Website during the year.

- Nightly backup of the website content.
- Secure handling of sensitive data transfer using 256-bit https certified connections.
- Secure storage of data in industry standard and compliant UK-based data centres.

• If required, the management and retention of a domain name commencing on the date stipulated on the invoice for the product or on some other date if agreed upon by both My Surgery Website and the client. The domain name will be renewed biannually 30 days before expiry. Domains may be transferred at the client's request to an alternative provider at no cost by My Surgery Website within 30 days of the request.

• If we manage the domain on your behalf. To do this we will register it using the My Surgery Website Nominet account and details. Domains are registered and managed via Nominet. Please see their <u>Terms and Conditions of Domain Name Registration</u> for more details.

Orders

The client shall confirm an order to My Surgery Website in writing or in email correspondence. The client shall be responsible for ensuring the accuracy of the terms of any order (including any applicable specification) submitted by the client, and for giving My Surgery Website all necessary information in relation to the transfer and/or redirection of domain names within a sufficient time to enable My Surgery Website to supply the product at the agreed time. The exact specifications for the Product shall be those set out in My Surgery Website's quotation or acknowledgement of order.

Price

Prices charged in any quotation are exclusive of VAT, unless otherwise stated. Annual licence charges may increase in line with inflation without prior notice. Any increase in fee beyond a reasonable rise to account for inflation will be preceded by an email notification at least one month prior to the rise.

Payment

Payment is due within 30 days of receipt of the invoice. My Surgery Website reserves the right to remove the product from the Internet where payment is not received in accordance with any alternative terms of payment agreed in writing. No cash or other discount is allowed unless agreed in writing by My Surgery Website.

Copyright

Copyright of all material originated by My Surgery Website, either in the form of pre contract documentation or as text, images, research papers or electronically stored code for the manipulation, transmission and presentation of information, remains vested in My Surgery Website. The client agrees to indemnify My Surgery Website against all liabilities costs, damage, damages and expenses which My Surgery Website may incur as a result of content added to the site by the client and which involve infringement of any copyright, patent or other intellectual or property right.

Liability

Termination

My Surgery Website may terminate this agreement immediately if the client fails to pay any sum due under it on the due date (time being of the essence regarding payment) or immediately if the client commits a material breach of any term of this agreement and which (in the case of a breach capable of being remedied) has not been remedied within 7 days of a written request remedy the same from My Surgery Website. Any termination of this contract shall be without prejudice to any of My Surgery Website's other rights or remedies.

Personal Information

Any personal information retained on this system is stored in a secure data centre located in the UK and is treated as confidential. Where appropriate, this data is deleted six months after its creation. Data is retained beyond six months only in the following circumstances:



- Prescription requests of registered patients are retained for one year so that users may view a useful request history.
- Prescription requests that have not been dealt with by the practice are retained for one year to provide an audit trail.
- Personal information of registered users used during the repeat request process is retained unless deleted by the user.
